MEMORANDUM FOR SEE DISTRIBUTION

SUBJECT: Camp Roberts Alcohol Policy

1. References:

- a. AR 215-1, Morale, Welfare and Recreations Activities and Nonappropriated Fund Instrumentalities, dated 24 September 2010.
- b. AR 600-85, Army Substance Abuse Program (ASAP), dated 2 February 2009 (rapid action revision dated 2 December 2009).
- c. DA Pamphlet 600-85, Army Substance Abuse Program (ASAP) Civilian Services, dated 15 October 2001.
- d. Department of Defense Directive, Number 1010.4 Subject: Drug and Alcohol Abuse by DoD Personnel, 3 September 1997, Incorporating Change 1, dated 11 January 1999.
- e. Camp Roberts Senior Commander's Intent:

(1) **Applicability:** This policy applies to all military and civilian personnel assigned, attached, or visiting Camp Roberts.

(2) **Purpose:** To provide an alcohol policy at Camp Roberts.

(3) **Implementation:** This policy will remain in effect until rescinded or superseded.

2. General Policy.

a. Alcohol abuse is inconsistent with Army values and mission readiness. Alcohol should not become the purpose for, or focus of, any social activity. At Camp Roberts, alcohol will not be glamorized or made the center of attention at any social activity to include special occasions or events.

b. All military and civilian supervisors will ensure subordinates are aware of this policy. The minimum age for purchasing, possessing, and consuming alcoholic beverages is 21. Underage drinking is prohibited.

c. All military and civilian personnel are prohibited from consuming alcoholic beverages during duty hours. On-duty status is determined by a military or civilian supervisor and is not necessarily related to uniform wear or the normal duty hours of an installation.

d. Civilian personnel who violate this policy may receive adverse disciplinary action to include removal from service. Military personnel who violate this policy may receive disciplinary action under the UCMJ (*see also CMVC*) or appropriate adverse administrative action.

e. Open containers of alcoholic beverages will not be consumed or possessed in publically accessible outdoor areas or in publically accessible facilities. Open containers of alcoholic beverages will not be consumed or stored in automobiles, barracks, or work areas.

f. All military and civilian supervisors will enforce Camp Roberts alcohol policy. This includes among other things policing their assigned buildings, barracks, and billeting areas.

g. No private parties with alcohol are allowed in billeting and CTQ common areas without written authorization from the billeting manager.

h. Alcohol is not permitted in barracks, training areas, or ranges.

### 3. Alcohol Consumption for Special Occasions and Events.

a. A Brigade Commander or first O-6 in the chain of command may submit a written request **within 10 days** for alcohol consumption at special occasions and events to the Army Division Commander or Designated Representative. All written request for alcohol consumption will include a risk assessment. If alcohol consumption for special occasion or event is approved in writing by the Army Division Commander or Designated Representative then a copy of memo approving special occasion or event will be forwarded to the Garrison Commander.

b. If a special occasion or event is approved for alcohol consumption then the senior ranking official assumes responsibility for participants' behavior. The senior ranking official, Garrison Commander, Emergency Services, and Security Forces reserve the right to stop all alcohol consumption or terminate the special occasion or event if they believe the activity is disturbing others, creates an unsafe condition, or is contrary to good order and discipline.

c. Commanders may request to hold special occasions or events involving alcohol consumption at Ball Field Recreation Center and at Building 113.

### 4. Sale of Alcohol Beverages.

a. Alcoholic beverages will be sold only at authorized facilities or events and will operate in accordance with hours approved by me, the Senior Commander. Military personnel will not purchase alcohol while in uniform between the hours of 1000-1600.

b. Serving more than one alcoholic drink at a time to a customer is prohibited. Serving alcoholic beverages to a visibly intoxicated person is prohibited.


c. Reduced prices or providing unlimited alcoholic beverages for special occasions or events are prohibited.

d. Solicitation for orders of alcoholic drinks just prior to the closing of an authorized facility, special occasion, or event (i.e., "last calls", "take out orders", etc.) is prohibited.

e. Authorized facilities are not allowed to sponsor events featuring open bar promotions where the price of the event includes unlimited alcohol beverages or feature monthly drink specials where the price of an individual drink is reduced.

f. This policy does not prohibit the sales of alcohol to Servicemembers and civilians off-duty, to authorized patrons, or authorized special functions. This policy does not restrict package store sales of alcohol intended for off-duty consumption.

MEMORANDUM FOR SEE DISTRIBUTION

SUBJECT: Alcohol Consumption Waiver Authority for Joint Forces Training Base – Los Alamitos, Camp San Luis Obispo and Camp Roberts Maneuver Training Center

1. The consumption of alcohol for the following CAARNG facilities: Joint Forces Training Base – Los Alamitos, Camp San Luis Obispo and Camp Roberts Maneuver Training Center is prohibited during duty hours by personnel in uniform unless an alcohol consumption waiver is granted.
2. Members of non-tenant units visiting these installations for the purpose of unit training are prohibited from the consumption of alcoholic beverages.
3. The appointed full time Senior Commanders of the named CAARNG training facilities in accordance with AR 600-20, Chapter 2, paragraph 2-5, are hereby granted waiver authority on alcohol consumption requests that have received concurrence through the unit's chain of command.
