SUBJECT: Full-Time National Guard Duty Qualifying for a Reduced Eligibility Age for  
Receipt of Retired Pay for Non-Regular Service

Pursuant to paragraph 5d of Enclosure 3 of DoD Instruction 1215.07, I have determined that Full-time National Guard duty (FTNGD) performed under section 502(f) of title 32, U.S.C., at the National Special Security Events listed below was pursuant to a call to active service by a Governor, was authorized by the President or the Secretary of Defense to deter or respond to acts of terrorism, and was for the purpose of responding to the national emergency declared in Proclamation 7463 of September 14, 2001. Accordingly, I designate any such FTNGD as qualifying active service for the purpose of reducing the eligibility age for receipt of retired pay for non-regular service in accordance with title 10, United States Code, section 12731(f)(2).
