## Report of the Results of Investigation MDIG-22-007

1. PURPOSE AND AUTHORITY: The California Military Department Inspector General (CMD-IG) Office received an anonymous complaint regarding a State Active Duty (SAD) Major General (MG), on or around 7 January 2022. The complaint alleged an SAD MG's executive assistant, (civil service employee) arranged vacation /personal travel plans for him and his spouse. On 28 February 2022, The Office of Governor Newsom directed the CMD-IG to investigate and report on the allegation that an SAD MG misused government personnel or government resources.

## 2. **COMPLAINANT STATUS**: Anonymous

3. <u>ALLEGATION:</u> Determine whether an SAD MG misused government personnel or resources for personal use in violation of Joint Ethics Regulation (JER) 5500-07, 2-301, 3-303(b), CMD Regulation 600-1, Chapter 12, Code of Ethics, 12(a)(7), and California Government Code § 8314.

## 4. SUMMARY AND FINDINGS:

**ALLEGATION:** The allegation that an SAD MG misused government personnel for personal services **was substantiated**. The preponderance of evidence indicated that an SAD MG did improperly have his Executive Assistant (civil service employee) arrange his and his spouse's personal travel for vacation in violation of (JER) 5500-07, 3-303(b), CMD Regulation 600-1, Chapter 12, Code of Ethics,12(a)(7), and California Government Code § 8314(a).

This office determined that the allegation that an SAD MG misused government communication systems or other government issued equipment in violation of JER 5500-7, 2-301 **was not substantiated**. The preponderance of evidence indicated that the duration and frequency of use did not adversely affect CMD operations, or the performance of the employees' official duties.
