**Redacted Report of the Results of Investigation
MDIG-25-018**

1. **PURPOSE AND AUTHORITY:** The California Military Department Inspector General (CMD-IG) Office received a complaint regarding a State Active Duty (SAD) Brigadier General (BG) (CA), on or around 13 January 2025. The complaint indicated that an SAD BG (CA) failed to foster a healthy work environment, failed to treat subordinates with dignity and respect, failed to report his time and attendance accurately, failed to submit a Serious Incident Report, and, lastly, failed to remove a member from Youth Programs who had concerning pending criminal charges.
2. **COMPLAINANT STATUS:** COL (CA)/06 / Previous SAD member
3. **ALLEGATION:**
 - a. **ALLEGATION 1:** Determine whether BG (CA), Youth Community Programs Task Force (YCPTF), failed to foster a safe and healthy work environment for CMD Service Members and/or employees in violation of AR 600-20 and TAG Policy, SUBJECT: Safe Workplace Community, over the past 12 months.
 - b. **ALLEGATION 2:** Determine whether BG (CA) failed to treat his service members and/or employees with dignity and respect by communicating in an unprofessional manner in violation of AR 600-20, CMDR 600-1 (Chapter 2), and TAG Policy, SUBJECT: Safe Workplace Community, over the past 12 months.
 - c. **ALLEGATION 3:** Determine whether BG (CA) failed to follow requirements for accountability and documentation of his time and attendance in violation of CMDR 600-1 and/or State Personnel Office (SP) policies over the past 12 months.
 - d. **ALLEGATION 4:** Any other relevant related matters, including mitigating or aggravating factors concerning the allegations above.
 - e. **ALLEGATION 5:** Determine whether BG (CA) violated any policies or regulations by failing to timely submit a Serious Incident Report (SIR) regarding a SAD CW2 (CA) criminal charges on or around 27 January 2021.
 - f. **ALLEGATION 6:** Determine whether BG (CA) violated any policies or regulations by failing to timely remove a SAD CW2 (CA) from duty assignments involving youth following his criminal charges on or around 27 January 2021.
4. **SUMMARY AND FINDINGS:** Based on the preponderance of the evidence, there is insufficient evidence to support the six allegations made against BG (CA); therefore, the CMD IG concludes that these allegations (references 1-6) are **not substantiated**.
